

TIKTOK VIDEO CONTEST 2023

TERMS & CONDITIONS

1. **Organiser.** TikTok Video Contest 2023 (the Contest) is organised by Land Surveyors Board (LSB), Singapore.
2. **Eligibility:**
 - a. The Contest is open to anyone aged 12 years or over, residing in Singapore, excluding LSB Board Members, Registrar and Deputy Registrar.
3. **How to Join:**
 - a. Participants have to fulfil the following steps to be eligible for the competition from **1 Feb 2023 to 28 Feb 2023**.
 - i) Show your creativity, editing and production skills with a TikTok video creation (in English only) related to land surveying in Singapore and impress your audiences and local TikTok community
 - ii) Upload it on your personal TikTok account with the hashtag #landsurveyingSG, #globalsurveyorsday, #surveyorsday
 - iii) Follow LSB's TikTok page/account (@lsb_sg) and ensure that your TikTok account is set to public
 - iv) Each participant is allowed to submit ONLY one (1) entry during the Contest Period
 - b. All TikTok profiles must be publicly viewable.
 - c. There is no entry fee and no purchase necessary to enter this competition.
 - d. The Contest will run from 1 Feb 2023 to 28 Feb 2023 at 12pm. Successful participants will be shortlisted and videos re-posted on LSB's TikTok page/account. Public voting will run from 1 March 2023 to 14 Mar 2023 at 12pm.
 - e. There will be 3 winners for this contest who will be receiving cash prizes in Singapore dollars of \$1000, \$300 and \$200 for the 1st, 2nd and 3rd prizes respectively via electronic bank transfer only. As such, all winners must have a valid bank account in Singapore and provide the necessary bank details to LSB in order for LSB to transfer the prize amount to the winners electronically.
 - f. All applications submitted after the specified date, or submitted through any other means other than as specified above, will not be eligible for the Contest. Any correspondence on missing and/or delayed submissions shall not be entertained.
 - g. Submissions that are found to be duplicates of another person's submission will be disqualified at the discretion of LSB.
 - h. The submission must not have previously won or been submitted for any professional awards/prizes and/or used previously in any marketing or advertising campaigns. Any discrepancy in participant's particulars may lead to disqualification at the sole discretion of the Organiser.
 - i. Only one (1) Entry per Participant will be considered, even if multiple entries are submitted.
4. **Contest and Prizes:**
 - a. The judging criteria is:
 - 50%: Number of likes on the videos
 - 50%: Creativity judged by LSB Board Members
 - b. The shortlisted winner will be contacted by the Organiser via TikTok direct message (DM) and provided with an email address that they need to send their contact details

to for verification purposes. The shortlisted winner must respond within the time frame stated in the message.

- c. If the shortlisted winner does not respond in time or provide incomplete information as required in the message, LSB reserves the right to forfeit the prize and contact a replacement winner.
 - d. Upon confirmation of eligibility, the Organiser will inform the winner on the details of prize collection and the prize is non-transferrable. The shortlisted winner must respond within the time frame stated in the message and confirm the intent to collect the prize.
 - e. LSB reserves the right to replace any prize with items of similar value without prior notice.
 - f. The selected winner will be notified to collect the prize at a given venue, date and time. LSB is unable to accede to other collection means or request.
 - g. Valid NRIC, FIN or passport must be presented for sighting and verification purposes only.
 - h. In the event that any winning participant is disqualified, LSB may, at its own discretion, select another winner.
 - i. LSB reserves the right to alter or terminate the Contest at its own discretion.
 - j. The participant maintains the copyrights to all of the images/video/content submitted. The participant must own all submitted images/video/content. If the participant submits images/video/content that doesn't belong to him/her, the entry will be disqualified. By submitting the images/video/content, the participant grants LSB the right to re-post/share/use the submitted images/video/content anywhere worldwide.
5. **Agreement to Terms.** By posting a TikTok video entry as a submission (the Submission) to the contest, each participant agrees to be bounded by these Terms and Conditions, including consent to LSB's collection of your personal data in order to conduct the Contest and agree that LSB may, for this purpose, collect, use and/or disclose your personal data in accordance with these Terms and Conditions. LSB reserves the right to amend the Terms and Conditions of the Contest, at any time, without prior notice.
