To whom it may concern

**SURVEY SERVICES UPON EXPIRY OF THE 4-YEAR TRANSITIONAL PERIOD UNDER THE LAND SURVEYORS (AMENDMENT) ACT**

When the Land Surveyors (Amendment) Act came into operation on 1.3.2000, the Land Surveyors Board issued LSB Circular No. 3/2000 to organisations which may have engaged surveyors for survey services. A copy of the circular which is self-explanatory is attached.

2 The 4-year transitional period as provided under Section 10 of the Land Surveyors (Amendment) Act will expire on 29.2.2004.

3 The Land Surveyors Act requires every land surveyor (and not only land surveyors who conduct cadastral surveys) to be registered. Any person who is not a registered surveyor, or any company which is not licensed by the Board, will be contravening the Act if the person or the company carries out any survey work in Singapore with effect from 1.3.2004.

4 This circular on the expiry of the 4-year transitional period is for your information as your organisation may have engaged surveyors for survey services.

**LSB CIRCULAR NO. 3/2000**

TO WHOM IT MAY CONCERN

**LAND SURVEYORS (AMENDMENT) ACT  
(ACT 34 OF 1999)**

Please be informed that the Land Surveyors (Amendment) Act comes into operation on 1 Mar 2000.

2 The Act requires every land surveyor (and not only land surveyors who conduct cadastral surveys) to be registered. However, those who have been providing survey services other than cadastral survey work shall be allowed to practise for four years wef 1 Mar 2000. The four-year grace period will enable them to sit and pass the examinations prescribed by the Board in order for them to be registered. On expiry of the four-year period, a further grace period of two years may be granted by the Minister for Law on a case to case basis.
